

# 'BJP-RSS event': Congress says no to Ayodhya invite

Some party leaders say they will attend Ram temple consecration on Jan 22

New Delhi, 10 January

The Congress on Wednesday turned down the invitations to its leadership to attend the January 22 consecration, or pran pratishtha, of the Ram temple in Ayodhya. The move indicates the party is prepared to fight a prolonged ideological battle on the issue if needed, even at the cost of any electoral reverses rather than surrender to Sangh Parivar's Hindutva politics.

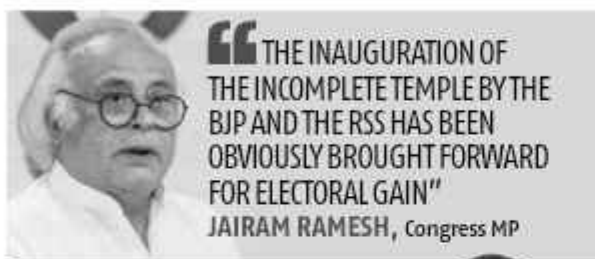
"The inauguration of the incomplete temple by the Bharatiya Janata Party (BJP) and the Rashtriya Swayamsevak Sangh (RSS) has been obviously brought forward for electoral gain," the Congress stated in a statement issued by party's General Secretary (communication) Jairam Ramesh.

The Congress said millions in India worshipped Lord Ram and pointed out that religion was a personal matter, "but the RSS and the BJP have long made a political project of the temple in Ayodhya".

"While abiding by the 2019 Supreme Court judgment and honouring the sentiments of millions who revere Lord Ram, Mallikarjun Kharge, Sonia Gandhi, and Adhir Ranjan Chowdhury have respectfully declined the invitation to what is clearly an RSS-BJP event," Ramesh said.

Last month, Congress President Kharge, Congress parliamentary party chairperson Sonia Gandhi and the party's leader in the Lok Sabha, Chowdhury, were invited to attend the inauguration ceremony.

However, some of the Congress' state units and leaders, such as Himachal Pradesh Chief Minister Sukhinder Singh Sukhu, have announced they would attend the ceremony. Vikramaditya Singh, a minister in the Sukhu-led gov-

**Manipur okays Cong yatra venue; BJP national council meet in Feb**

The Manipur government on Wednesday approved the venue for the flagging off of Rahul Gandhi-led Bharat Jodo Nyay Yatra from Imphal's Palace Ground on January 14 "with limited number of participants". According to Congress General Secretary (organisation) K C Venugopal and former Congress chief minister Okram Ibobi Singh met Chief Minister N Biren Singh to seek permission and conveyed that the party would not politicise the Manipur ethnic strife. The Manipur government has, however, refused to allow the party holding a public rally.

Meanwhile, the Bharatiya Janata Party is likely to hold its national council meeting in mid-February in Delhi, with nearly 10,000 BJP leaders from across the country attending it. The three-day meet will have the party's top leadership speak about its campaign pitch for the 2024 Lok Sabha polls.

emment and the son of former chief minister Virbhadr Singh, has said he would attend the ceremony and thanked the Vishva Hindu Parishad (VHP) for the invite. In a post on X, Congress Gujarat legislator Arjun Modhwadia, a former party state unit chief, criticised his party's decision. "Lord Ram is worshipped by the people of the country. It is a matter of their faith. The Congress should have refrained from taking such a political decision."

After Communist Party of India (Marxist) General Secretary Sitaram Yechury declined the Ram temple

the Purvamnaya Govardhan Peetham of Puri, told the media on Tuesday: "When (Narendra) Modi Ji will do the consecration at the temple and will touch the idol, will I be going there to clap?" He said people should think what was left for dharmacharya (religious preachers) to do in Ayodhya if the prime minister was doing everything, but lauded him for showing respect to Sanatan Dharma.

Swami Avimukteshwaranand Saraswati, 1008th Shankaracharya of the Jyotish Peeth in Uttarakhand, said the inauguration of the partially constructed temple was inconsistent with tradition and being done for political gains. Some religious leaders have also pointed to senior VHP leader Champat Rai's comments that the Ram temple belonged to the Ramanand sect and its followers and not to Shankaracharyas, Shaivas and Shaktas.

The Congress' response to Hinduva politics has been inconsistent in recent years. In the 2019 Lok Sabha polls, the Congress social media team highlighted the party's role in the construction of the Ram temple, pointing out that the locks to the makeshift temple inside the disputed Babri Masjid were opened during the party's rule in Uttar Pradesh in 1986, and Rajiv Gandhi's role in facilitating shilanyas of the temple the same year. In 1989, Rajiv Gandhi launched the Congress Lok Sabha campaign from Ayodhya.

In turning down the invite, the Congress has joined some of its INDIA bloc allies. Another ally, Samajwadi Party's chief Akhilesh Yadav, on Tuesday said he would visit the temple later. "The BJP and its associated wings are nobody to send such an invitation to me on behalf of God. I'll worship only when God calls me," Yadav said.

# Shinde faction real Shiv Sena, rules Maharashtra Speaker

In a relief to Maharashtra Chief Minister Eknath Shinde, Assembly Speaker Rahul Narwekar on Wednesday held that the Shiv Sena faction led by him was the "real political party" when rival groups emerged in June 2022.

Shiv Sena (UBT) chief Uddhav Thackeray the decision was a murder of democracy, and his party will move the Supreme Court against it. In his 105-minute long reading of the key points of the ruling, Rahul Narwekar also rejected Uddhav Thackeray faction's petition to disqualify 16 Shiv Sena MLAs, including Shinde.

As Narwekar finished reading the order, celebrations broke out among Chief Minister Shinde's supporters, who burst firecrackers, while Sena (UBT) leaders Sanjay Raut and Aaditya Thackeray said their party will approach Supreme Court against the Speaker's order.

NCP leader Sharad Pawar said Uddhav Thackeray will

have to approach the apex court against the ruling of the Speaker, who gave precedence to the legislature party. Narwekar said no party leadership can use provision of 10th schedule of

MLAs, Narwekar said Sunil Prabhu of the Sena (UBT) ceased to be the whip from June 21, 2022, and Bharat Gogawale of the Shinde group became the authorised whip.

"All the petitions seeking disqualification of MLAs are rejected. No MLA is being disqualified," Narwekar said. The Speaker also held that the Shiv Sena pramukh (chief) did not have the power to remove any leader from the party. He also did not accept the argument that the will of the party chief and the will of the party were synonymous.

"This is BJP's conspiracy and this was their dream that one day they would finish Balasaheb Thackeray's Shiv Sena. But Shiv Sena won't finish with this one decision. We will go to the Supreme Court," Raut said.

Narwekar said he could not accept petitioner's (Uddhav faction) contention that the 2018 party constitution should be relied upon.

Shiv Sena constitution of 1999, provided by the Election Commission is the real constitution, he said.

# WEF: Misinformation current risk; extreme weather long-term threat

With close to 300 crore people expected to head to elections across countries in two years, misinformation and societal polarisation have emerged among the biggest immediate risks before the world, a global study showed on Wednesday.

In the case of India alone, "misinformation and disinformation" poses the top-most threat in the next two years, the World Economic Forum (WEF) said in its annual *Global Risks Report*. It is followed by infectious diseases, illicit economic activity, income inequality and labour shortage among the five biggest short-term risks.

On a longer-term horizon of ten years, the biggest global risk would be from extreme weather events. The report warned of a global risk landscape in which progress in human development is being chipped away slowly, leaving states and individuals vulnerable to new and resurgent risks.

"Against a backdrop of systemic shifts in global power dynamics, climate, technology and demographics, global risks are stretching the world's adaptive capacity to its limit," the WEF said. The report, released ahead of the WEF's five-day annual meeting in Davos beginning January 15, argued that cooperation on urgent global issues could be in increasingly short supply, requiring new approaches to addressing risks.

## Green H2 can enable India's net-zero journey

Green hydrogen in India can not only provide energy for sectors such as fertilizers, chemicals, refining and iron, but also save carbon emissions compared to fossil fuels, the World Economic Forum said. In an analysis of what it will take to make green hydrogen a credible energy pathway, the report said, "Green hydrogen can enable energy transition as India takes its net-zero journey towards 2070."
